this issue and this is what we found out from Orange County Code Enforcement.

Short term rentals are considered transient rentals. Transient rentals are any stay in a dwelling of 179 days or less. These are allowed only in one zoning code in Orange County. That is zoning code R3. Summerfield is in Orange County zoning code PD, for Planned Devlopment. Because of this zoning code designation short term rentals are not allowed in Summerfield by Orange County. This includes Air BnB rentals. Anyone renting out a unit on a short term basis can be issued a citation and face fines from the County. Also, this activity is not permissible per the Summerfield Covenants and must cease.

Some owners have stated they are grandfathered in since they have been doing this for years. The County Code Enforcement official we spoke with said that the activity would have had to start before October 07, 1957, in order to have that designation. Since Summerfield was built almost 40 years after that date this exemption will not apply to any short term rentals in Summerfield.

Also, some of the owners have stated they have been collecting fees and taxes for the State, therefore they have been abiding by all of the codes and laws. Orange County also stated this is not true. Collection and remittance of any taxes and fees does not make this activity in complaince with the ordinances.

Finally, Code Enforcement stated that there are many Orlando

Sentinel articles written concerning this activity and are readily available on the internet. Also, you may call the Orange County Information Hotline by dilaing 311 and ask to speak to Code Enforcement if you need any more informaton concerning this topic. We hope this helps everyone understand why short term rentals are not allowed in Summerfield at Meadow Woods and we hope for everyone's cooperation regarding this issue.

Summerfield Parking Issues

We are pleased to announce that new parking stickers will be issued to all residents in the next few weeks. The Board will set up the days and times for residents to get their new parking decals at the pool soon.

Please be aware that anyone parking on the street leading up to the community will be ticketed and possibly towed by the Orange County Sheriff's Parking Enforcement Division and our off duty Deputies starting in June. Please cease this activity as this is a hazard for motorists trying to use this road for ingress and egress to the communities. Thank you.

Summerfield Irrigation System

Many residents have already noticed that we have started the repairs on the irrigation system for Summerfield. These repairs have just started and will be ongoing for several weeks. During the firt phase we are just getting the valves to work and the breaks in the

water main repaired. Once this is done we will start concentrating on the individual zones and broken heads or heads that are watering sidewalks and not watering the grass! This system has been inactive for quite sometime and it will take us several weeks to complete. Memorial Day

Memorial Day began as a memorial for Civil War veterans. It has become both a National Decoration Day of family graves, and the holiday that opens the summer season. It is celebrated with backyard barbecues, outdoor picnics, and parades.

Waterloo, New York was recognized by President Lyndon Johnson and both houses of Congress, as the birthplace of Memorial Day because the town decorated the graves of Civil War veterans as early as May 5, 1866. The claim is contested by Boalsburg, Pennsylvania, which claims to have begun the practice of decorating soldier's graves two years earlier than Waterloo. Another source claims that two years after the Civil War, it was southern women in Columbus, Mississippi who decorated the graves of both Confederate and Union men. Nevertheless, sources agree that it was General John A. Logan of the Grand Army of the Republic who designated May 30, 1868," as a day for strewing with flowers or otherwise decorating the graves of comrades who died in defense of their country, and whose bodies now lie in almost every city, village, or hamlet churchyard in the land...It is the purpose of the commander-in-chief to inaugurate this observance with the hope that it will be kept from year to year while a survivor of the war remains to honor the memory of the departed."

No survivor of that war remains, but the memories of it grow longer. As do our memories of the parades with floats; civic organizations and drum majorettes twirling their batons; lines and lines of young veterans from The Gulf War and shorter lines of older men who saw service in the Second World War. As long as there are wars, there will be veterans and casualties. We will still decorate the graves of those men whose bodies came home and remember those

that don't.

The custom of placing flowers upon graves is an old one and exists in many countries. The Greeks had rites called zoai, which were performed over each new grave. If the flowers took root and blossomed on the graves, it meant the souls were sending back the message that they had found happiness. The Roman festival, called Parentalia, or Day of the Fathers, lasted for eight days in February-violets and roses were the special flowers. Whatever the flower, wherever the grave, this placing of flowers upon graves has always seemed the natural thing to do.

Today, most states officially recognize the May Memorial Day as a legal holiday, but it is not celebrated on May 30th in every state. Over time the holiday has expanded to encompass our other national wars. Although Veteran's Day is celebrated as well, Memorial Day has become the most important day of recognition of our armed forces.

A Time To Remember

For more than one hundred years, Americans have honored those who died defending their country with Memorial Day services. Often there are parades leading to burial sites or the Tomb of the Unknown Soldier. In coastal areas, floral tributes are strewn over the water in loving memory.

We join with our friends and co-workers on May 28th in honoring all of these heroes, known and unknown, who sacrificed their own lives to make our country great.

World **Environment Day**

World Environment Day is held each year on June 5. It is one of the principal vehicles through which the United Nations (UN) stimulates worldwide awareness of the environment and enhances political attention and action.

What Do People Do?

World Environment Day is celebrated in many ways in countries such as Kenya, New

Zealand, Poland, Spain and the United States. Activities include street rallies and

parades, as well as concerts, tree planting, and clean-up campaigns. In many countries, this annual event is used to enhance political attention and action towards improving the environment. This observance also provides an opportunity to sign or ratify international environmental conventions.

Public Life

The UN World Environment Day is not a public holiday, so public life is not affected.

Background

World Environment Day was established by the United Nations General Assembly in 1972 to mark the opening of the Stockholm Conference on the Human Environment. Another resolution. adopted by the General Assembly the same day, led to the creation of UNEP. It is hosted every year by a different city and commemorated with an international exposition through the week of June 5.

Symbols

The main colors featured in many promotions for this event are natural colors depicting nature, the Earth and its natural resources. These colors are often softer shades of green, brown and blue. Images of natural the Earth's features, such as snowy mountains, clean beaches. unpolluted rivers, and photos of natural flora and fauna, including fern leaves, are used to promote campaigns supporting the day.

Flag Day in the **United States**

Deople across the United States celebrate Flag Day on June 14 each year to honor the United States flag and to commemorate the flag's adoption. On the same day, the United States Army celebrates its birthday.

What Do People Do?

Flag Day falls within National Flag Week, a time when Americans reflect on the foundations of the

nation's freedom. The flag of the United States represents freedom and has been an enduring symbol of the country's ideals since its early days. During both events, Americans also remember their loyalty to the nation, reaffirm their belief in liberty and justice, and observe the nation's unity.

Many people in the United States honor this day by displaying the American flag at homes and public buildings. Other popular ways of observing this holiday include: flag-raising ceremonies; Flag Day services; school quizzes and essay competitions about the American flag; musical salutes; street parades; and awards for

special recognition.

Organizations such as The National Flag Day Foundation are actively involved in coordinating activities centered on the event and keeping the flag's traditions alive. Following Flag Day is Honor America Days, a 21-day period through to Independence Day (July 4) to honor America. During this period, people hold public gatherings and activities to celebrate and honor the nation.

Public Life

Although Flag Day is a nationwide observance, it is not a public holiday in many parts of the United States. It is a legal holiday in a few areas in the USA, such as Montour County in Pennsylvania.

Background

On June 14, 1777, the Continental Congress replaced the British symbols of the Grand Union flag with a new design featuring 13 white stars in a circle on a field of blue and 13 red and

confinued

white stripes – one for each state. Although it is not certain, this flag may have been made by the Philadelphia seamstress Betsy Ross, who was an official flag maker for the Pennsylvania Navy. The number of stars increased as the new states entered the Union, but the number of stripes stopped at 15 and was later returned to 13.

In June 1886 Bernard Cigrand made his first public proposal for the annual observance of the birth of the flag when he wrote an article titled "The Fourteenth of June" in the old Chicago Argus newspaper. Cigrand's effort to ensure national observance of Flag Day finally came when President Woodrow Wilson issued a proclamation calling for a nationwide observance of the event on June 14, 1916. However, Flag Day did not become official until August 1949, when President Harry Truman signed the legislation and proclaimed June 14 as Flag Day. In 1966, Congress also requested that the President issue annually a proclamation designating the week in which June 14 occurs as National Flag Week.

The President is requested to issue each year a proclamation to: call on government officials in the USA to display the flag of the United States on all government

buildings on Flag Day; and to urge US residents to observe Flag



Day as the anniversary of the adoption on June 14, 1777, by the Continental Congress of the Stars and Stripes as the official flag of the United States.

Symbols

The American flag, also nicknamed as "Old Glory" or "starspangled banner", has changed designs over the centuries. It consists of 13 equal horizontal stripes of red (top and bottom) alternating with white, with a blue rectangle in the canton bearing 50 small, white, five-pointed stars. Each of the 50 stars represents one of the 50 states in the United States and the 13 stripes represent the original 13 colonies that became the first states in the Union.

Change A/C Filter

For those who have perished for my right of freedom of flight, those who will die, and indeed, for those who would live. I stand as a symbol of freedom saving people!


